

THE KHYBER MEDICAL UNIVERSITY FEES AND OTHER CHARGES STATUTES 2008

WHEREAS it is expedient to regulate the University fees and other charges, the University Syndicate, under Section 27(1)(b) of Khyber Medical University Act 2006 (NWFP Act No. I of 2007) framed the following Statutes;

1. Short title and commencement: (1) These Statutes may be called as "Khyber Medical University Fees and Other Charges Statutes 2008";
- (2) These shall come into force at once;
2. The following fees / charges shall be payable / charged by the University against the mentioned activities, services and documentations etc.
